It is not too late to enroll!

Enrollment is open all year if you are eligible for:

- Medicaid
- Child Health Plus
- Essential Plan

What is a Special Enrollment Period?

A Special Enrollment Period is when someone experiences a "Qualifying Life Event" that makes them eligible to enroll in or change their coverage through a Qualified Health Plan (QHP) outside of the Open Enrollment Period. This may include:

- Loss of health insurance (for reasons other than you did not pay your premium)
- Permanent move into New York State (you must have had other coverage within the past 60 days)
- Marriage or Domestic partnership (you must have had other coverage within the past 60 days)
- Divorce or legal separation
- Pregnancy, birth or adoption of a child, or placement of a child in foster care
- Becoming eligible or ineligible for help paying for your Qualified Health Plan coverage.
- Becoming a citizen, national or lawfully present individual

You must report a Qualifying Life Event to NY State of Health within 60 days.

如果您符合以下項目的資格，則投保是全年開放的：

- 政府醫療補助
- 兒童保健計劃
- 基本計劃

什麼是特殊投保期間？

特殊投保期間是某人遇到特殊人生大事(稱為「合格的人生大事」)而使他們有資格透過開放投保期間以外的合格健康計劃(QHP)投保或變更其承保範圍的時間。合格的人生大事包括：

- 失去健康保險(因您並未支付保費以外的原因)
- 永久搬到紐約州或在使您有資格享受新健康計畫的州內搬家(您必須在過去 60 天內有其他保險)
- 婚姻或同居伴侶關係(您必須在過去 60 天內有其他保險)
- 離婚或合法分居
- 懷孕，出生或收養小孩，或安置寄養小孩
- 獲得或失去接受協助支付合格的健康計劃承保的資格
- 取得公民、國民或合法居留身分

您必須在 60 天內向 NY State of Health 報告合格的人生大事。
